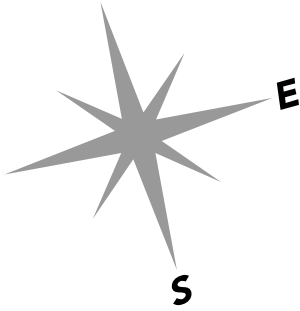

**DEFINITIONS:**

**Facilities:** Hangar facilities and amenities of the South East Ramp.
